**BOARD REPORTS** 

Madam Deja Vu Deux, DJ Ruscik

- a) **July 50/50:** Suggestions made by Madam D.J. Ruscik to donate July 50/50 to either Pine Island Food Pantry or to Lilly's Deli in support of "Robin Lilly's Mission" giving out free food to unemployed locals. Motion by Natalie Gazda to approve donation to Lilly's Deli; motion passed.
- b) Financial requests: None
- c) **Hooker business: Fall elections** Billie Young interested in being on Nominating Committee. Nominations August & September; "meet the candidates" in October meeting; voting/election in November meeting. Board will take office 1/1/2021. Do Directors need to be full time residents? Discuss at July General meeting.
- d) **State of Florida** Madam Déjà vu Deux updated Board on "situation" regarding our possible non-compliance with a FL State Statute. DJ shared that we have an annual certification due for the State of Florida under statute 496.4055(2) called "**Annual Certification of Compliance with Conflict of Interest Policy**". She passed around the details for compliance and made a motion to adopt this policy per the guidelines provided by the state. Motion passed.

- e) General Membership Upcoming Meetings July 15 [Wednesday] Natalie Gazda gave report on Moose Lodge available space for JULY 15 General Meeting. We can have a maximum of nine member tables with 4 to 5 per table; no head or merchandise tables so we can accommodate members. 32 for quorum. Meeting must be done by 8 PM. Doors open at 5 PM for dinner; meeting @ 6 PM.
  - <u>August 10 [Monday]</u> @ Bert's Billie to contact Bert's to confirm they have available space with required distancing requirements & whether we would have food. Also will check with other venues such as the Elks.
- f) Matlacha Hookers' trailer still on Chamber property. DJ Ruscik attended Chamber meeting to hear status of property [Madam Déjà vu Deux is still officially Mango Queen.] Jennifer Jennings [former GPI Chamber Director] still has our trailer key & planned to give it to either Genie or Billie. Plans underway to obtain key & DJ to contact manager Kathy of our storage unit location to get cost to possibly move our trailer there.
