

MATLACHA HOOKERS GENERAL MEETING MINUTES – Moose Lodge, Pine Island July 15, 2020

Call to Order by Madam Deja Vu Deux at 6:30 PM Pledge of Allegiance led by Madam Deja Vu Deux Invocation by Grateful Genie, Chaplain

BOARD REPORTS

Madam Deja Vu Deux, DJ Ruscik

- a) Madam DJ advised group that tonight we have 16 members in attendance in person and five members on on-line web conference call. This is not a quorum [32] so no motions/official voting will be done tonight.
- b) **50/50:** Board approved motion to donate July 50/50 to Little Lilly's Deli in support of "Robin Lilly's Mission" of providing meals for those unemployed locals because of the shutdown. We will proceed with this donation without motion.
- c) Hooker Business: Fall elections Nominations for Officer & Director Board positions August & September; "meet the candidates" in October meeting; voting/election in November meeting. We have six Directors & five Officers; will vote 11/9/20 for three Directors & four Officers. Madam emphasized that it is understood that Board members may occasionally miss meetings. New Board will take office 1/1/2021. Question posed earlier: Do Directors need to be full time residents? Answer: Yes for efficiency.
- d) Financial Requests: None
- e) State of Florida Madam Déjà vu Deux recently updated Board on "situation" regarding our possible non-compliance with a FL State Statute. Madam DJ shared that we have an annual certification due for the State of Florida under statute 496.4055(2) called "Annual Certification of Compliance with Conflict of Interest Policy". She gave the Board the details for compliance and a motion to adopt this policy per the guidelines provided by the State was approved. Madam DJ is still negotiating with the State regarding possible fine & timeline.
- f) Website/Hooker Heralds/Facebook Hooker Herald will be published 3x/month on 10th, 20th & 30th, then published on Face Book & on our website. Submissions at least two days previously. Suggestion from Karen Durand that HH be published at least 48 hours prior to General Meeting each month [instead of firmly on the 10th]; consideration will be given this suggestion on how to implement & standardize.
- g) General Membership August Meeting: date & location TBD. Check your Hooker Herald.
- h) Matlacha Hookers' trailer currently on Chamber property. DJ Ruscik attended Chamber meeting to hear status of property. [Madam Déjà vu Deux is still officially Mango Queen!] Jennifer Jennings [GPI Chamber Director] returned our trailer key. Because the Chamber office is not open every day and, in an abundance of caution about furloughed

our trailer's security, we are moving our trailer this week to same storage facility as our Hooker Hut [Doug Taylor Circle]. Billie was quoted a monthly fee of \$150 for both our Hooker Hut & trailer storage.

UPDATE SINCE MEETING: Our trailer is too long for any of the currently available spaces at storage facility on Doug Taylor Circle. For the immediate future, Madam DJ is pursuing our getting a new trailer lock for door and wheel lock & chain.
