Release of Liability and Waiver

2025 Pine Island Elementary Fishing Tournament & Derby

In consideration of me, as well as anyone under the age of 18 who is in my care, custody or supervision while participating in the Derby, being allowed to participate in any way or manner during or in the 2025 Pine Island Elementary Fishing Tournament & Derby and its related events and activities (collectively herein, the "Derby"), the undersigned, being at least 18 years of age and of sound mind, acknowledges and agrees as follows:

1. The risk of injury from the activities involved in the Derby is significant, including the potential for permanent paralysis or death; and while skill, equipment, and personal discipline may reduce this risk, the risk of serious injury or death still exists.
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES (as defined below) or others; and I assume full responsibility for my participation in the Derby as well as the participation in the Derby of anyone under the age of 18 who is in my care, custody or supervision.
3. I will comply with and will cause anyone under the age of 18 who is in my care, custody or supervision to comply with the stated and customary rules, regulations, terms and conditions of the Derby. Further, if I observe any hazard condition during my presence or participation in the Derby, I will remove myself and anyone under the age of 18 who is in my care, custody or supervision from the hazardous condition and will immediately bring the hazardous condition to the attention of the Tournament Director; and
4. I, for myself and on behalf of my successors, heirs, assigns, personal representatives and next of kin, and on behalf anyone under the age of 18 who is in my care, custody or supervision, HEREBY RELEASE, AND AGREE TO INDEMNIFY AND HOLD HARMLESS, (i) the Matlacha Hookers, Inc., a Florida not for profit corporation, Jug Creek Marina, and their respective shareholders, members, partners, directors, officers, employees, agents, officials, volunteers, sponsors, advertisers, affiliates, and subsidiaries, (ii) other participants in the Derby, and (iii) the owners and/or lessors of any premises used in the Derby (collectively herein, the "Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO ANY PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERS, resulting from or with respect to my participation in the Derby or the participation in the Derby of anyone under the age of 18 who is in my care, custody or supervision, in each case to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND WAIVER, FULLY UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND I AM SIGNING IT FREELY AND VOLUNTARILY.
