b) Outreach report: 2 rent payments granted each for \$200. and 1 \$600. medical payment

Home visits have been temporarily suspended. Question of whether to bend the policy of recipients only being allowed 1 payment per 12 month period due to the covid-19 crisis. Also on that topic, we may get requests for financial assistance from laid-off people who live off island but make their living on the island. We have always helped only island residents. Is there a process to bend that rule if necessary? Members discussed and agreed that these decisions should be left to the Outreach committee's discretion. A couple in St. James City has donated \$500. in Winn Dixie gift cards to Outreach.

EVENTS AND ACTIVITIES

1: Fundraisers

a) Scholarships:deadline extended to May 1/20, currently \$10,477.86 is available for scholarships. 3 applications have been received. Kathy Foley has offered to sponsor a 2nd scholarship this year for a male.

b) Merchandise Report: Jill Filgut reported that donations for merchandise at the Mullet Toss was approx. \$600. Small and medium sized shirts are in low supply, an order for approx. \$800. is to come as well as an order for wine cups at \$200. Members agreed that any order in excess of \$1,000. requires general membership approval.

Surplus food items will be offered to members via a flyer attached to the Herald and on our website.

c) Wine Event: Final profit \$5,820.05. The committee will organize a wrap-up to determine the final amount to be given to the Beacon of Hope for their senior's programs.

d) Bag'n Tag: Final profit \$2,450.91. Billie recommended discontinuation of the bake sale for 2021.

2: Community Support

a) Adopt-A-Road:scheduled for April 29th has been cancelled, to be scheduled again in June.
